Accordingly, the original allegations were effectively dropped, and a demand of INR 25.29 Lakhs was raised, comprising GST of INR 14.25 Lakhs, interest of INR 9.62 Lakhs, and penalty of INR 1.42 Lakhs.</p> <p>The Company believed that it had a strong case on merits against the demand order received and would file an appeal before the appropriate authority against the said order.</p>	The Company had filed an appeal with the Office of the Joint Commissioner of Commercial Taxes in Karnataka on March 28, 2026.
